CALL TO ORDER

THE PROCEEDINGS OF THE ANNUAL TOWN MEETING OF DEKALB TOWNSHIP, DEKALB COUNTY, DEKALB, ILLINOIS WAS HELD ON TUESDAY, <u>APRIL 12, 2011</u> AT THE DEKALB TOWNSHIP OFFICE, 2323 SOUTH FOURTH STREET, DEKALB, ILLINOIS. THE MEETING WAS CALLED TO ORDER BY CHAIRMAN MICHAEL SHANE, BY ACCLAMATION DUE TO ABSENCE OF TOWNSHIP CLERK, AT 7:00 PM AND KURT SCHWEITZER LED US IN THE PLEDGE OF ALLEGIAINCE.
