

Minutes, Board of Town Trustees DeKalb, Illinois Annual Town Meeting April 12th, 2016

The meeting was called to order at 7:00pm by Township Clerk Geralynne Kunde at the Township offices located at 2323 South Fourth Street in DeKalb, Illinois.

Clerk Kunde gave a brief welcome to all Town members in attendance and proceeded to introduce the Township Officials present. Those acknowledged were: Supervisor Eric Johnson, Road Commissioner Craig Smith, Township Assessor John Hietikko, and Township Trustees Kurt Schweitzer and Lisa King.

Clerk Kunde asked for a motion to be made to set the meeting Moderator's pay at \$50.00 for the evening. The motion was made by Craig Smith and seconded by John Hietikko. Motion passed.

Moderator Dyer announced that the next Annual Town meeting is scheduled for April 9th, 2017 at 7pm. Craig Smith made a motion to set the meeting for April 9th, 2017 and was seconded by Lisa King. Motion passed.

Announcements and Comments from the floor: There were none.

A motion was made by John Hietikko to adjourn the meeting, with a second from Craig Smith. Motion passed.

Moderator Dyer ended the meeting in regular manner at 7:07pm.
